FSC[™]-Certified Paper Packaging Statement

1. Purpose

This statement outlines Logitech's commitment to using FSC[™]-Certified paper packaging and provides transparency regarding our use of the Forest Stewardship Council (FSC) logo. As part of our transition from recycled plastic to paper, we are embracing FSC-certified paper to ensure a responsible paper packaging supply chain. This complements our Single-Use Plastic Packaging Policy, reinforcing our commitment to reducing environmental impact and promoting responsible sourcing of packaging materials.

2. Scope

This statement applies to all FSC-certified paper packaging components used in Logitech products, including packaging for retail, and promotional purposes. It also covers Logitech's trademark license to use the FSC logo for off-product promotions and the due diligence processes we undertake to ensure that all relevant suppliers hold valid FSC chain-of-custody certifications.

3. Our Objectives

Logitech's objectives can be summarized as follows.

- Ensure responsible paper sourcing by using FSC-certified paper packaging.
- Enhance transparency in FSC logo use and supplier certification requirements.
- Reduce environmental impact by transitioning from recycled plastic to responsibly sourced paper.
- Verify supplier compliance through due diligence, monitoring, and audits.
- Maintain FSC trademark integrity by ensuring accurate and responsible use of the FSC logo.

4. Logitech's FSC Trademark License

Logitech Europe S.A. holds a trademark license to use the FSC logo for off-product promotions under license number **FSC-N003028**. We use the FSC logo thoughtfully, ensuring it accurately reflects our collaboration with certified suppliers and our commitment to sustainable practices in supply chain management.

5. On-product FSC Logo

The FSC logo on the consumer-facing packaging (e.g., boxes, outer packaging) is the FSC chain-of-custody certification from the packaging supplier contracted to provide the packaging. Before displaying the FSC logo, Logitech conducts thorough due diligence to verify that all relevant suppliers of paper-based packaging components hold valid FSC chain-of-custody certifications. This ensures that the FSC logo reflects our suppliers' responsible forest resource management practices.

6. Supplier Requirements

Logitech requires the following from all suppliers of FSC-certified paper-based packaging components:

- **FSC Chain-of-Custody Certification:** Suppliers must hold valid FSC chain-of-custody certifications to use the FSC logo on packaging.
- **Certification Documentation:** Suppliers must provide evidence of their FSC certification status.
- **Packaging Compliance:** All materials must meet FSC standards, ensuring traceability from forest to final product.
- **Ongoing Certification:** Logitech actively monitors and ensures that suppliers maintain their certification and align with our sustainability goals.

7. Compliance Assurance

To ensure adherence to this policy, Logitech will:

- Monitor Certification: Actively monitor and verify that suppliers hold valid FSC chain-of-custody certifications.
- Audits and Documentation: Conduct audits and request certification documentation as part of our due diligence process.
- Non-Compliance Management: Suppliers found non-compliant with FSC certification requirements must rectify the issue or risk a reevaluation of their partnership with Logitech.



• Responsible Use of FSC Logo: Ensure the FSC logo is used accurately and responsibly in alignment with our sustainability commitments.
